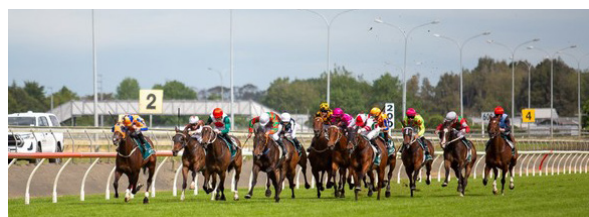

KEYNOTE SPEAKER



Peter Nation

Peter Nation is a prominent figure in New Zealand's agricultural sector, best known for his tenure as the Chief Executive Officer (CEO) of the New Zealand National Fieldays Society, the organisation behind the Southern Hemisphere's largest agricultural event, Fieldays. His association with the society spans nearly three decades, culminating in his appointment as CEO in March 2016.

Before stepping into the role of CEO, Nation was deeply involved with the society in various capacities. He served as the major sponsor representative during his tenure as ANZ's Regional Manager Rural, where he supported significant capital projects, including the development of the Mystery Creek Pavilion. His extensive experience in the agricultural sector and his commitment to the society's mission made him a natural fit for the leadership position.

During his leadership, Nation navigated the organisation through several challenges, most notably the disruptions caused by the COVID-19 pandemic. He successfully steered the society's event business during these turbulent times, ensuring the continued prominence of Fieldays in New Zealand's agricultural calendar. Reflecting on this period, Nation remarked that successfully navigating such upheaval would undoubtedly go down as one of his highlights.

In September 2024, after eight years at the helm, Nation announced his decision to step down as CEO, effective December 2024. He expressed a desire to pursue personal interests and spend more time with family, stating, "I have made the decision to step aside so I can pursue more personal interests and time with family." He also expressed confidence in the society's future, noting that he felt he was leaving it in a very stable position with a bright future ahead.

Peter has since moved to chairing the Waikato Chamber of Commerce and doing his own consultancy work. For someone who had been attending Chamber meetings from the age of 17, giving back to the Chamber with his free time came naturally.

Throughout his career, Peter Nation has been a passionate advocate for New Zealand's agricultural sector. His leadership at the New Zealand National Fieldays Society has left a lasting impact, reinforcing the significance of agriculture in the nation's economy and culture.

DISCUSSION PANEL

Brent is an Elected Director of Fonterra and had a 25-year career in both New Zealand and abroad in various corporate advisory roles, including being a Partner at PwC for more than 12 years. He is a fellow of the Chartered Accountants of Australia and New Zealand. He currently Chairs the Board of Waitomo Group Limited and Better Eggs Limited, and is a Director of Rabobank NZ Limited and Power Farming Holdings Limited.

Brent is actively involved as a shareholder of two dairy operations in the Waikato.
